REQUIREMENTS FOR ABSTRACTS

File format - MS Word, sheet format - A5, margins - 1.0 cm, font - Time New Roman 10 pt, line spacing - 1, text alignment in width, paragraph - 1.0 cm, figures - black and white (grouped), volume - 1-2 full pages. The rubrication of abstracts should contain the following data:

- initials and surname of the author (s) (right-justified, bold),
- initials and surname of the scientific advisor, academic degree and academic title (alignment on the right, bold),
- the name of the organization where the author (s) works or studies (right-aligned, bold),
- title of abstracts (in capital letters, centre alignment, bold),
- presentation of theses,
- a list of sources used (if necessary), drawn up in accordance with current requirements.

The names of the files with the conference materials must correspond to the surname of the first co-author.

Students add a paper version of the thesis signed by the author (s) to the electronic carrier and for students - by the supervisor. The authors are responsible for the content and accuracy of the submitted materials. The presented materials are published in the author's edition.
