TERMS OF PARTICIPATION IN THE CONFERENCE:

1. By 05 April 2024, send to the organizing committee's email address dep.constitutionallaw@btsau.edu.ua the abstract (Gonchar_Abstracts.doc) and the author's reference (Gonchar_About the author.doc).

- 2. The volume of abstracts -2-4 pages, not numbered.
- 3. Format A4, text processor MS Word, margins: top, bottom, right, left 20 mm.
- 4. Font Times New Roman, size 14, line spacing 1,5, paragraph 1,25 sm.
- 5. Structure of the report:

The title of the report in the middle of the line (in capital letters).

Below, one space apart, on the left – surname and initials, scientific degree, academic rank (if available), position, department, full name of the institution where the author studies or works.

- 6. Below, one space apart, your abstracts are placed.
- 7. The **summary** in Ukrainian is placed 10 mm below the title of the theses, typed with a paragraph indent in Times New Roman font of 12 pt with single line spacing and aligned in width.
- 8. **Keywords** (5–6) are required below the **summary**.
- 9. At the end of the text at one interval **References** (bold and centered) to literary sources are submitted in accordance with the requirements of DSTU 2015. In the text, references are indicated by square brackets with the serial number of the source in the list followed by a comma, page numbers, for example: [7, p. 16].
- 10. When designing literature, you should follow the National Standard of Ukraine DSTU 8302:2015 "Information and documentation" developed in 2015. Bibliographic reference. General provisions and rules of drafting".

The editorial team reserves the right to edit the submitted materials, as well as to reject them in case of inconsistency with the Conference topic and non-compliance with the above conditions. It is not responsible for the authenticity of the facts presented.

Prohibition of using scientific works of the occupying country

It is prohibited citing and including in the reference list russian-language contributions published in any country, incl. papers written in other languages but published in russia and belarus.
